Forces Extends Centre Armed (SpecialPowers) Act (AFSPA) In Eight **Districts Of Nagaland**

- Centre has extended the The Armed Forces (SpecialPowers) Act (AFSPA) in eight districts of Nagaland and three districts of Arunachal Pradesh with effect from 1st of next month.
- It has also been extended to 21 police stations in five other districts of Nagaland and three police stations in another district of Arunachal Pradesh.
- The AFSPA has been in force in certain districts and police station areas in Nagaland and Arunachal Pradesh for many years now and it is extended periodically.
- In a notification, the Union Home Ministry said that a further review of the law and order situation in the states of Nagaland and Arunachal Pradesh has been undertaken.
- Therefore, Dimapur, Niuland, Chumoukedima, Mon, Kiphire, Noklak, Phek and Peren districts in Nagaland and the areas falling within the jurisdiction of six police stations eachin Mokokchung and Zunheboto districts, four in Kohima, three in Wokha and one in Longleng are declared as disturbed areas for six months from April 1.

Nidhu Saxena named MD & CEO of Bank of Maharashtra

- Bank of Maharashtra announced the appointment of Nidhu Saxena, Executive Director, Union Bank of India as its Managing Director and Chief Executive Officer (MD & CEO).
- The appointment is for a period of three years with effect from the date of assumption of office, that is, from March 27, 2024 or until further orders, whichever is earlier.
- Nidhu Saxena will be replacing AS Rajeev upon his selection as Vigilance Commissioner in CVC.
- Nidhu Saxena started his banking career at Bank of Baroda and later moved to UCO Bank.
- He has over 26 years of experience working in diversified areas of banking. Prior to joining Bank of Maharashtra, he was the Executive Director of Union Bank of India. During his tenure, he worked in all key banking functions and has been in several positions such as Branch Head, Zonal Head and Vertical Head. He also has 8 years of experience in the corporate sector before he started his banking career.

Florida Passes Law Banning Social Media for Minors Under 14

- Florida Gov. Ron DeSantis signed legislation that prohibits people under 14 years old from having social-media accounts, regardless of parental consent, one of the most restrictive laws aimed at curbing social-media access for minors.
- Under the new law, social-media companies are required to close accounts believed to be used by minors under 14. The platforms must also cancel accounts at the request of parents or minors, and all information from the accounts must be deleted.
- The law is set to take effect on Jan. 1, 2025.
- Minors who are 14- or 15-years old can obtain a social-media account with parental consent, according to the new law. Accounts already belonging to teens of that age must be deleted if a parent or guardian hasn't consented.


Reliance buys 26% stake in Adani Power's unit

- Mukesh Ambani's Reliance Industries has bought a 26 per cent stake in a Madhya Pradesh power project of Gautam Adani, and signed a pact to use the plant's 500 MW of electricity for captive use. This is the first business collaboration between the two billionaires.
- RIL entered into an investment agreement with Mahan Energen, a wholly-owned subsidiary of Adani Power, where 50 million equity shares are to be allotted to RIL.
- It is India's Electricity Rules, 2005, that has prompted RIL to pick a stake in Adani Power's unit.
- RIL has entered into a 20-year power purchase agreement with Mahan for its captive use.
- RIL has said the investment agreement was following the provisions of the Electricity Rules, 2005, in terms of which it, as a captive user, is required to own 26 per cent proportionate ownership in one unit of Mahan of 600 megawatt (Mw), with RIL being the captive user of 500 Mw.

- In this connection, ISRO solicits Expression of Interest (EOI) to host START-2024 in educational institutes, universities, colleges within India who are offering UG and PG courses in physical sciences and technology.
- The main objective of the training programme is to attract the youngsters to the fields of space science and technology.
- The training modules will comprise introductory level topics on various verticals of space science and technology. In addition to these, there will be sessions on Indian space exploration programmes and research opportunities.

Kotak Mahindra Bank acquires 100% stake in Sonata Finance

- Kotak Mahindra Bank announced the successful acquisition of Sonata Finance Private Limited ("Sonata").
- This acquisition, finalized for a total consideration of approximately Rs. 537 crore, marks Kotak Mahindra Bank's full ownership of Sonata.
- As previously communicated in February 2023 and October 2023, the Bank had expressed its intention to acquire Sonata.
- Sonata, a Non-Banking Finance Company Micro Finance Institution (NBFC-MFI) registered with the Reserve Bank of India (RBI), operates across 10 states through 549 branches. As of December 31, 2023, it boasted an impressive Asset Under Management (AUM) of approximately Rs. 2,620 crore.

South Korean Ambassador to Australia resigns

- Ambassador to Australia Lee Jong-sup stepped down, less than a month after he was named for amid mounting criticism of job, appointment and departure that came despite the fact that he was subject to an investigation.
- Lee faced public scrutiny since he was appointed as the ambassador to Australia, seeing as how he was banned from leaving the country due to an investigation led against him for his alleged meddling in an internal military probe into a South Korean marine's death last year.
- Lee, having been the defense minister at the time, supposedly advised one of the country's military officials to withhold information relevant to the death that was being investigated in 2023.
